1. Overview

Coming out of COVID, coupled with the need to secure future core funding, 2022/23 has been a transitional and challenging year for the Birkbeck Institute for the Study of Antisemitism (BISA). Nevertheless, it has been a productive one and ended strongly, notably securing core funding from the Open Society Foundations which will enable the Institute to continue its research, teaching and outward-facing activities to comprehend and tackle antisemitism.

BISA's reputation for research excellence has been underscored with the publication of two books by Institute staff and a significant presence at conferences in Europe, the USA and Israel, as well as visiting fellowships and teaching posts.

The Institute's public policy work has extended in new directions this year, engaging with international actors in the ongoing debates around the definitions of antisemitism. This has included presentations to the United Nations Alliance of Civilizations, the United Nations International Commission of Inquiry on the Occupied Palestinian Territory and the United Nations High Commissioner for Human Rights, as well as providing a briefing paper to the Domestic Policy Council in the USA.

The Institute returned to in-person events this year, hosting a three-day international conference in January and reinstating its popular film screenings and discussions.

3. Research

PUBLICATIONS

David Feldman and Marc Volovici's co-edited volume of essays, *Antisemitism, Islamophobia and the Politics of Definition*, was published in June 2023 by Palgrave Macmillan. It is part of the book series Palgrave Critical Studies of Antisemitism and Racism (series editor: David Feldman). In this volume, which arose out of an Institute workshop, historians, social scientists and philosophers reflect on definitions of antisemitism and Islamophobia in both the past and the present. The essays explore the historical roots of present-day debates and consider how and why definitions of antisemitism and Islamophobia have become a site of fierce political contestation in recent years.

Brendan McGeever (with Satnam Virdee) has published *Britain in Fragments: Why Things Are Falling Apart* (Manchester University Press). The book explores how Britain, one of the most dominant states in world history, finds itself confronted with growing demands for nationalist secessionism. Meanwhile, class, gender, regional and generational inequalities are deepening and endemic racism has been reinvigorated. The authors trace how successive governments have incrementally dismantled the democratic settlement which has culminated in a crisis of representation and legitimacy.

ACADEMIC EVENTS

BISA co-organized and hosted the seventh international, multidisciplinary conference 'Beyond Camps and Forced Labour, Current International Research on Survivors of Nazi Persecution'. The three-day conference was attended by over 100 speakers and included two public events. This important triennial conference is a collaboration between BISA, The Wiener Holocaust Library, Imperial War Museum Institute, the Holocaust Research Institute at Royal Holloway, University of London and the University of Wolverhampton.

The Institute took the decision to continue to hold its academic seminars online. This brings two benefits: a seminar programme which secures international speakers and increasingly attracts an international audience of scholars. Topics considered this year included: antisemitism in France; James Baldwin and Holocaust exceptionalism and Black revolt; and the return of the xenophobic right.

Research

EARLY CAREER FELLOWS

Three early career fellows have been in post this academic year. They have made a valuable contribution in furthering BISA's international reputation and to its teaching and public events programme at Birkbeck.

Eliana Hadjisavvas has continued to work on her research project on British detention camps, funded by the Alfred Landecker Foundation. She has undertaken a number of international research trips, including to South Africa, where she conducted research at the National Archives in Pretoria and at the University of Cape Town's Kaplan Centre Archive. In May, she travelled to Israel to conduct research at the Central Zionist Archive and to begin the oral history dimension of her project, interviewing survivors. Alongside her research, Eliana has continued the development of her proposed exhibition with The Wiener Holocaust Library, which is scheduled to open in 2025/26. Eliana contributed to BISA's public events programme, arranging for US film producer Keith Beauchamp to attend the screening of his award-winning documentary *The Untold Story of Emmett Louis Till* and participate in a Q&A session. Eliana has made a successful application for a one-year fellowship at New York University's Remarque Institute. She will take up the post in September from where she will undertake her US-based research.

William Pimlott, Rothschild Foundation postdoctoral fellow, has continued his research project on the global Yiddish press, writing up his research on the Yiddish press in South Africa and Argentina for publication and spending one month completing archival research in Israel. He has presented his work in Yiddish at a symposium in Dusseldorf, and in English at conferences in London, Warsaw, Boston, Providence and Cape Town. His work has been published in the journal of Yiddish studies, *In Geveb*, and in the British Association for Victorian Studies tri-annual newsletter. William was awarded a three-month Visiting Lecturer post in Advanced East European Studies at Royal Holloway, University of London, which he held from January to March 2023. William has also contributed to the Institute's public events, with a successful application to the Birkbeck Institute for the Moving Image for joint funding of a film series on Yiddish Political Cinema which he chaired (see Public Engagement).

Jan Rybak, BISA Early Career Fellow, has undertaken a full programme of research and academic collaboration this year. In November and December, he conducted archival research in Warsaw and New York City. In January and February, he held a visiting fellowship at the Leibniz-Institut für jüdische Geschichte und Kulture – Simon Dubnow (DI); this was followed by two months in Israel for archival research and collaboration with the University of Haifa. In May and June, Jan held a visiting fellowship at the European University Institute, Florence. In July, he began a two-month research trip to the Czech Republic, Hungary, Austria, Poland and Lithuania. This final research trip was made possible by the award of a travel and research grant from the Fondation pour la Mémoire de la Shoah in Paris. Jan has given guest lectures in Leipzig and Haifa, and delivered conference papers in Boston, Hamburg and Bucharest. His work has been published in *European History Quarterly*, *German History*, *The Galitzianer* and *Haaretz*. Jan's book, *Everyday Zionism in East-Central Europe: Nation-Building in War and Revolution, 1914–1920* (Oxford University Press, 2021) received an honourable mention in the Rachel Feldhay Brenner Book Award for Polish-Jewish Studies, 2023..

4. Teaching

The MA module 'Antisemitism, Holocaust, Colonialism, Gender: Connecting the Conversations', supported by the Open Society University Network and delivered by the Institute in collaboration with Central European University, Bard College New York, SOAS and University of the Witwatersrand, ran for its second year. Some 40 students took the course, 19 of whom were from Birkbeck. The course is an important element in BISA's work to foster understanding of the interconnections between antisemitism, racism, racialization and ethno-nationalism.

The short course 'Facing Antisemitism: Politics, Culture, History', taught by David Feldman, Ben Gidley and Brendan McGeever, was delivered to staff and members of the University and College Union (UCU) in autumn 2022 and to the National Education Union in a hybrid format, online and in person, from January to March 2023.

Jan Rybak and Eliana Hadjisavvas have both contributed to teaching on BA modules and short courses in the Department of History, Classics and Archaeology.

5. Policy Engagement

Public policy work has taken up a great deal of time this year, centring on international debates on the various definitions of antisemitism. David Feldman was invited by the United Nations Alliance of Civilizations to speak at its ninth global forum, on 'Defining Antisemitism to Advance the UN Goal of: Forging a New Social Contract: Combating Discrimination and Intolerance Based on Religion or Belief Anchored in Human Rights'. His speech was widely circulated on social media and incorporated into a briefing on antisemitism given in the Italian Senate. Subsequent meetings have been held with the United Nations High Commissioner for Human Rights, Volker Türk and with the United Nations International Commission of Inquiry on the Occupied Palestinian Territory. In response to President Biden's initiative to develop a national strategy to counter antisemitism in the USA, David Feldman, together with Stefanie Schüler-Springorum, Technische Universität Berlin, prepared a briefing paper on 'Antisemitism: Lessons from Europe' for the US Domestic Policy Council at The White House.

At a European level, David Feldman has provided input to two important initiatives: a scoping report by Human Rights Watch to identify how best to develop programming to combat antisemitism in the UK, France and Germany, and a project initiated by the European Network for Countering Antisemitism through Education, which explores whether an intersectional approach – collaborating with networks that fight various forms of prejudice – would be beneficial in preventing antisemitism.

In the UK, BISA's expertise has been sought by numerous organizations on a diverse range of issues. The V&A invited David Feldman to a workshop with museum curators to consider how it should identify and address the Jewish dealers and collectors who contributed to its collection and how to exhibit Jewish objects. A national broadsheet and a Jewish communal organization both sought the Institute's advice on how to recognize and deal with specific forms of antisemitism. The UCU asked BISA to devise a survey into UCU's Jewish members' experiences at work, with their local UCU branch and UCU's headquarters. The campaign group, Hacked Off, approached the Institute for advice on how antisemitism should be addressed in the government's Online Safety Bill.

David Feldman has contributed to briefing notes for MPs on the government's policy paper, the '2030 Roadmap for UK-Israel Bilateral Relations' published by the Foreign, Commonwealth & Development Office in March, and on the Government's Economic Activities of Public Bodies (Overseas Matters) Bill, published in June, which seeks to prevent boycotts of Israel.

In the continuing discussions around definitions of antisemitism in the higher education sector, David Feldman has held briefing meetings with senior officials in the Department of Education's Student Experience and Widening Participation Directorate and the Higher Education Quality, Access and Student Experience Directorate. The University of Greenwich and the University of Warwick have also sought his expertise on this matter.

6. Public Engagement

This year, BISA returned to holding in-person public events, mounting seven during the year.

Highlights included the screening of the award-winning documentary *The Untold Story of Emmett Louis Till* (2005), produced and directed by Keith Beauchamp, which presents a compelling examination of racism in 1950s America. Keith Beauchamp attended the screening and took part in the discussion and Q&As that followed. This event was held in partnership with Birkbeck Institute for Social Research, the Department of History, Classics and Archaeology and the Raphael Samuel History Centre.

Film screenings, in collaboration with the Birkbeck Institute for the Moving Image, presented two rarely seen classic Yiddish films from the 1930s, *Grine Felder* and *Uncle Moses*. Both films explore the political options available to East European Jews in America and Europe before the Holocaust and offer fascinating insight into immigrant life and the modern Jewish experience. As part of the 'Beyond Camps' international conference, BISA also hosted its first concert, 'Yiddish Glory: The Lost Songs of World War II', with Grammy award-winning singer/songwriter Psoy Korolenko and Anna Shternshis, University of Toronto, providing the narration.

Public lectures have considered: 'Holocaust Memory in Eastern Europe'; 'Antisemitism, Racism, National Socialism and What Does this History Mean for Public Memory Today?'; and 'Is Antisemitism a Form of Racism?'.

7. The Institute in the Media

Ben Gidley and Jan Rybak published an op-ed ‘Why the West’s “Anti-war” Camp is so Hostile to Ukrainians – and to Jews’, in *Haaretz* in June 2023. The article considered the growing presence of antisemitic conspiracy theories since Russia’s invasion of Ukraine in 2022. Using the Institute’s concept of a ‘reservoir of antisemitism’, it explores how old narratives, often emanating from the Russian state and its media platforms, are being widely shared in both right-wing and left-wing political spaces.

Brendan McGeever appeared on BBC Radio 3’s *Free Thinking* programme ‘Gut Instinct’, in discussion with presenter Matthew Sweet and others. The far-ranging discussion about the gut and the brain encompassed racism, antisemitism and conspiracy theories, and was broadcast on 22 June 2023.

David Feldman has provided briefings and comment to: BBC Radio 4, *Jewish Currents*, *The Guardian*, *The i*, *The New York Times*, *The Pittsburgh Post-Gazette* and the World Service.

8. Future Funding

BISA has secured core funding from the Open Society Foundations' Education and Ideas Collaborative.

The funding will enable BISA to push ahead with an ambitious programme of research, policy and public engagement. This work will promote a better understanding of antisemitism in the present as well as in the past.
