1. Overview

The sharp rise in antisemitic incidents in many countries following Hamas' terrorist attack on Israel on 7 October 2023 and the unfolding war in Gaza has had a significant impact on BISA's activity and outputs this year.

Requests from the media – for interviews, for comment and for advice – have risen considerably and have come from a diverse range of outlets – from *Reuters* to *Rolling Stone*. Institute staff have been interviewed and quoted in UK, European and international titles. This has included several in-depth interviews in a wide range of publications, including *The New Yorker*.

Op-eds have also focused on the repercussions of events in the Middle East with open letters and articles published in *The New Statesman*, *The New York Review of Books* and *Vashti*.

International public policy work has also reflected events following 7 October. David Feldman was invited to participate in a two-day international roundtable on antisemitism and Islamophobia convened by the Ministry of Foreign Affairs for the State of Qatar. He was the invited speaker at a roundtable organized by The Nexus Project in the USA, attended by senior political figures and activists. The University of Pennsylvania also invited him to speak at a symposium held in response to events on US campuses.

3. Research

FUNDED RESEARCH

The transnational research project, 'Muslim–Jewish Encounter, Diversity and Distance in Urban Europe: Religion, Culture and Social Model', led by Ben Gidley and involving six European universities, completed its research phase in autumn 2023. This interdisciplinary project has explored the specificities and commonalities between Muslim–Jewish encounters in urban Europe and how these are shaped by different national histories of integration and by local arrangements of diversity. Dissemination of the results is underway: in October a workshop was held in Heidelberg and a public event in Berlin. The final report will be presented in Berlin, Brussels and Paris in autumn 2024.

The Arts and Humanities Research Council-funded project, 'Making and Remaking the Jewish East End; Space, Language and Time', undertaken in collaboration with Queen Mary, University of London, concluded in December 2023. David Feldman has written two research papers for publication as part of this project: one, co-written with Nadia Valman and Vivi Lachs, on the history and representations of Petticoat Lane and the other on Jews in the First World War.

Eliana Hadjisavvas was awarded the Remarque Institute Fellowship at New York University, September–December 2023.

PUBLICATIONS

Anthony Bale has published *A Travel Guide to the Middle Ages: The World through Medieval Eyes* (Viking Penguin, 2023). Written in the form of a modern handbook, and comprising historical and contemporary accounts of medieval travel, it seeks to capture the diverse social and intellectual cultures of the period and includes several sections about the history of antisemitism in terms of travel writing. The book has been translated into Dutch, German, Italian and Portuguese and published in paperback by Penguin in July 2024.

David Feldman has had a chapter entitled 'A Retreat from Universalism: Opposing and Defining Antisemitism and Islamophobia in Britain, ca. 1990–2018' published in Scott Ury and Guy Miron (eds.), *Antisemitism and the Politics of History* (Brandeis University Press, 2023).

Ben Gidley has had a paper published in *Patterns of Prejudice*, entitled 'Postcolonial Hauntings in Riverine London: Conviviality and Melancholia', which examines the East London neighbourhoods of Deptford and Barking, whose identity and urban morphology have been shaped by the River Thames which runs through them.

William Pimlott, a Postdoctoral Fellow at the Institute between 2021 and 2023, whose research focuses on the global Yiddish Press, has published in *Jewish Historical Studies* his research on South Africa undertaken while at BISA: 'The Yiddish Press and the Making of South African Jewry in the British World: Exclusion, Libel, and Jewish Nationalism, 1890–1914'.

Jan Rybak has had three papers published this year, submitted while he was an Early Career Fellow at the Institute (2021–2023): 'Building Pillars of the Nation: Zionist Care and Education for Galician Refugee Children in WW1 Austria', in *POLIN: Studies in Polish Jewry*; 'A Revolutionary Woman's Self-Emancipation: Malke Schorr's Childhood and Youth in East Galicia', in *Jewish History Quarterly*; and 'Emanzipation mit der Waffe: Zur historischen Verortung jüdischer Selbstverteidigung,' *Jüdische Geschichte & Kultur*, in *Magazin des Simon-Dubnow Instituts*.

Research

ACADEMIC EVENTS

The Institute co-convened a two-day international conference, 'Entangled Otherings: Islamophobia, Antisemitism and Philosemitism after October 7', in collaboration with the Cambridge Interfaith Programme, University of Cambridge, the Center for Research on Antisemitism, Technical University, Berlin and the Department of German Studies at Indiana University, Bloomington. The conference was funded by the German Academic Exchange Service (DAAD).

In partnership with the Leo Baeck Institute London, BISA hosted a workshop on 'Jewish Refugees in the British Empire, 1933–1948' led by Atina Grossman, Cooper Union. The aim of the workshop was to foster interdisciplinary dialogue and scholarly exchange on the experiences of Jewish refugees in the British Empire before, during and after the Holocaust. Eliana Hadjisavvas was co-convenor of the workshop which was supported by the Alfred Landecker Foundation.

The Institute's online seminars, of which there have been eight this year, have garnered a regular following, including international scholars, attracting audiences of between 50 and well over 100. Seminars under the rubric 'Antisemitism Now' have explored the politics of defining racism, discourse on antisemitism and responses to events before and after October 7, including the Israel/Palestine debate on US campuses and antisemitism and Jewish identity in the UK. Other seminars have considered Jewish prisoners of war, the relationship between antisemitism and racism and Jewish advocacy and anti-racism.

4. Teaching

Ben Gidley taught the core first year BA Psychosocial module, 'Hate' and the core final year BA Psychosocial module, 'Racism and Antisemitism', which is also open to students from other programmes and this year included those on community development, politics and social science BAs. Each module was taken by around 25 students.

David Feldman taught the MA module, 'Antisemitism, Holocaust, Colonialism, Gender: Connecting the Conversations', supported by the Open Society University Network (OSUN) and delivered by the Institute in collaboration with Central European University, SOAS and University of the Witwatersrand, which ran for its third year. The course was taken by 26 students, 17 of whom were from Birkbeck.

The National Education Union commissioned Birkbeck for the third consecutive year to run its short course, 'Facing Antisemitism: Politics, Culture, History' for members of the National Executive Committee and key staff, taught by David Feldman, Ben Gidley and Brendan McGeever.

David Feldman has given lectures on antisemitism and the left at the Leo Baeck College, London and as part of the ENCATE Certificate Program 'Current Forms of Antisemitism' for educators, civil society organizations and policy makers, organized by the Center for Research on Antisemitism, Technical University Berlin, and the Kreuzberger Initiative against Antisemitism.

Three research students, supervised by David Feldman, have been awarded their doctorates this year.

5. Policy Engagement

INTERNATIONAL

In February 2024, Ambassador Lipstadt, US Special Envoy to Monitor and Combat Antisemitism, met with David Feldman, Ben Gidley and Brendan McGeever to discuss BISA's work on antisemitism and the left.

In other international work, David Feldman was invited to participate in a two-day roundtable 'Combating Islamophobia and Antisemitism: New Grounds for Understanding and Policy', convened by the Ministry of Foreign Affairs for the State of Qatar and attended by experts from Europe, the USA and Qatar. He was also invited by The Nexus Project in the USA to speak at a roundtable on definitions of antisemitism and anti-Israel activity and antisemitism post 7 October, attended by senior US political figures and activists. The Nexus Project advocates full implementation of President Biden's National Strategy to Counter Antisemitism and against the use of false accusations of antisemitism as political weapons.

David Feldman is on the international advisory board of the Diaspora Alliance, which seeks to promote a multiracial, pluralistic democracy through tackling antisemitism alongside other forms of oppression and racist ideologies and violence.

UK

The Guardian newspaper invited David Feldman to meet with the editor, deputy editor and leader writers to discuss antisemitism and its definitions, especially in the context of discussion of Israel/Palestine and the current war in Gaza. Ben Gidley analysed social media posts for antisemitic content on behalf the UK editor of an international philanthropy magazine. The Institute gave extensive advice to the Diaspora Alliance and leading barristers on definitions of antisemitism, freedom of speech and government policy.

Other policy work has included input into teaching resources on antisemitism for the anti-racism educational charity Show Racism the Red Card, advising the Jewish advocacy group Na'amod on its approach to antisemitism, offering guidance on a satirical play about antisemitism and Jeremy Corbyn opening at the Edinburgh Festival Fringe and addressing a counter-terrorism conference on 'Anti-Zionism and Antisemitism Today' attended by personnel from the UK's specialist terrorist and extremist units, the police, prison and probation services.

David Feldman and Brendan McGeever are members of the Diaspora Alliance UK academic advisory board.

6. Public Engagement

BISA PUBLIC EVENTS

The Institute held 11 public lectures this year, just one of which was held online. The most popular lectures attracted audiences of well over 100 people. The Holocaust Memorial Lecture was attended by 175 people. Speakers have been drawn from the USA and Europe, as well as the UK. Overseas speakers have included: Ambassador Deborah E. Lipstadt (US Special Envoy to Monitor and Combat Antisemitism), Arie Dubnov (The George Washington University), Jennifer Evans (Carleton University), Laura Leibman (Reed College), Leo Lucassen (International Institute of Social History, Amsterdam) and Wolf Gruner (University of South California). Several eminent UK scholars have spoken at BISA this year: Jane Caplan (St Anthony's College, University of Oxford), Bryan Cheyette (University of Reading); Nissa Finney (University of St Andrews) and Frank Trentmann (Birkbeck, University of London).

The topics covered have been wide ranging, drawing on history, literature, geography, politics and art and include: Gaza in the Israeli imagination; multiracial Jews in the early Atlantic World; testimony in the transatlantic slave trade and Europe's forced labour camps; Jewish resistance in the Holocaust; how and when 'the Holocaust' became known by that name; Jewish refugees, trans communities and photography; contemporary Jewish identities and racism; antisemitism across the political divide; the rise of the far right; and the 1948 war in Palestine.

The Institute has partnered with the Institute for Historical Research, the Holocaust Research Institute at Royal Holloway, University of London, University College London and the Wiener Holocaust Library in mounting its programme of events.

To extend its reach, BISA has begun to upload all the podcasts in its archive (from 2010 to 2020) to its YouTube channel.

7. The Institute in the Media

The Institute has responded to unfolding events since 7 October with opinion pieces, interviews and commentary.

OPINION PIECES

In early November, an opinion piece by David Feldman and Brendan McGeever entitled 'On Slaughter and Solidarity' was published in *Vashti*. This article called for clear thinking in the face of the misleading characterizations of the slaughter and hostage-taking carried out by Hamas on 7 October 2023. Taking examples from history and the present, from Russia and the USA, Israel and Gaza, the piece called for clarity about antisemitism and the need to build 'a politics of human freedom ... that is clear sighted about racism in its multiple forms'.

In November 2023, David Feldman, with 15 other scholars of the Holocaust and antisemitism, was joint author/signatory to 'An Open letter on the Misuse of Holocaust Memory', published in the *New York Review of Books*. This argued that invoking Holocaust memory to explain the crisis in Gaza and Israel obscures understanding of antisemitism and misrepresents the causes of violence in Israel-Palestine. It urged public figures and people working in the media to stop using such comparisons, calling instead for speech and action aimed at preventing further loss of life. In December 2023, the *New York Review of Books* invited and published a follow-up open letter, also joint-authored by David Feldman, that responded to criticism of their position and expanded upon their original arguments.

In February 2024, at the invitation of the *New Statesman*, David Feldman wrote an opinion piece on 'Britain's Antisemitism Problem', examining the resurgence in antisemitism in 2023 and drawing on BISA's concept of a reservoir of antisemitism to explain how stereotypes and conspiracy theories about Jews have become a part of our common culture.

In June 2024, the Dutch weekly news magazine *De Groene Amsterdammer* published an essay by David Feldman entitled 'How the Politics of Anti-racism and those of Anti-antisemitism Have Drifted Apart'. This took as its starting point the divergent responses to the attack on Israel by Hamas on 7 October and the war in Gaza to explore the history of attempts to oppose antisemitism and how the politics of anti-racism and those of anti-antisemitism, closely aligned after the Second World War, have gradually drifted apart – a disconnect that is strikingly visible in the present moment.

INTERVIEWS

The *New Yorker*, *El País* (Spanish and English editions), the Dutch weekly journal *NRC Handelsblad* (republished in Italian in *Internazionale*), and the online journal of intellectual capital *Thought Economics* have published in-depth interviews with David Feldman, which explore the origins and history of antisemitism, how to criticize Israel without being antisemitic and the relationship between antisemitism and anti-Zionism. German national TV ZDF / 3Sat broadcast an interview with David Feldman on the rise of antisemitism and criticism of Israel in the war in Gaza.

Ben Gidley has given in-depth interviews to the Norwegian weekly journal *Morgenbladet* about the relationship between antisemitism studies and the study of anti-racism, and to both the French daily online newspaper AOC, and the German weekly newspaper *Jungle World*, on antisemitism and anti-Zionism on the left.

COMMENTARY

Media outlets, in the UK and internationally, have sought the Institute's guidance on discourse on Israel and Palestine, how to define antisemitism and whether specific statements and objects are antisemitic.

Insight and comments from BISA academics on these issues have appeared in: *Al Jazeera*, *Business Insider*, *Court House News*, the *National News US*, *Reuters*, *Rolling Stone*, *The Telegraph* and *Zerkalo* (a Belarusian media outlet) among other titles. Background briefings have been given to *Al Monitor*, *Associated Press*, the *BBC*, *Jewish Currents*, *Sky News*, *The Guardian*, *The Herald* (Scotland) and the *Toronto Star*.
